

# (15) Description of equipment:

The intrinsically safe Feature Phone of type Ex-Handy 10 \*\*\* DZ2 is communication device intended for use in hazardous areas of zones 2 and 22. The device provide additional features such as camera, GPS, NFC, acceleration sensor, WiFi, Bluetooth, vibration motor, headphone connector, magnetic sensor and flash-light. Different integrated antennas can be used for the usual cellular systems. The device is equipped with a non-exchangeable integrated Li-lon battery unit. Charging and wired data transfer is done via the magnetic USB-connector in ordinary locations only.

The battery pack is only allowed to be charged outside of the classified hazardous location.

The device has to be protected against strong impacts.

The SIM-Card-Cover for card access must be screwed tight before entering the hazardous location.

The device shall not repaired or dismantled (except the SIM-Card-Cover in ordinary locations).

It is allowed to use the 3.5 mm Audio Plug in the hazardous locations for connections to certified accessory meeting the following entity parameters:
